Ground Transportation

Taxicab service at the domestic terminal is located in the Ground Transportation Center/West Curb, immediately outside and between W-1 and W-2 door. For

international terminal, taxicab service is located on the arrival level outside the A-1 door.

Rideshare services are available at the airport. Currently, only Uber and Lyft are the rideshare companies authorized to pick up from the airport. Pickups in domestic terminal is located at the North Economy lot. Meanwhile, pickups in international terminal is located at the arrival level outer curb.
