**SUBJECT : UPDATES AND CALL FOR PARTICIPATION ON SOLIDARITY
CAMPAIGN IN SUPPORT FOR NORDECO**

Greetings of Peace and Solidarity from PHILRECA!

This is to inform you that the House Bill No. 11072 entitled, “*An Act Including Tagum City, The Island Garden City of Samal, and the Municipalities of Asuncion, Kapalong, New Corella, San Isidro and Talaingod, in the Province of Davao Del Norte, and the Municipalities of Compostela, Laak, Mabini, Maco, Maragusan, Mawab, Monkayo, Montevista, Nabunturan, New Bataan and Pantukan, in the Province of Davao De Oro to the Franchise Area of the Davao Light and Power Company, Inc., Amending for the Purpose Republic Act No. 11515,*” **was already forwarded to the Office of the President at the Malacañang for signing of President Ferdinand Marcos, Jr.**

Under the process of enacting a law, the President will either sign the final enrolled bill into law, or veto and send it back to the Senate with a veto message. In cases of no action from the President, the bill will be deemed approved after thirty (30) days upon receipt.

In this regard, we urge all electric cooperatives (ECs) and League of Electric Cooperatives Information and Communication Officers Nationwide, Inc. (LEXICON) members to express our unwavering support for NORDECO in its fight against private-for-profit takeover by the DLPC.

All ECs are hereby encouraged to participate in the solidarity campaign through the posting of the EC Unified Statement on **12 March 2025, Wednesday at 1:00 PM**. Attached is the copy and the link for the template art card for your reference.
