Greetings of Peace and Solidarity from PHILRECA!

This is in reference to the recently approved "Revised Rules Governing the Automatic Cost Adjustments and True-Up Mechanisms and Corresponding Confirmation Process for Distribution Utilities" by the Energy Regulatory Commission (ERC).

To instruct the correct manner of completing the Revised Uniform Reportorial Requirement (URR) spreadsheet template and train the concerned personnel of the electric cooperatives, the ERC, in partnership with PHILRECA, will be conducting onsite training workshop.

All electric cooperatives are expected to partake in the said training workshop which will start on the last week of January 2023 (please see attachment for tentative schedule). The Commission is requiring at least two (2) personnel per EC to attend the training workshop – one (1) from the department in-charge in the computation of over or under recoveries and URR submission and one (1) from the Technical Department in-charge of the Metered Data submissions used in the computation of the System Loss Rates. PHILRECA, however, recommends at least four (4) representatives per EC to attend – two (2) from each of the said department consisting of one (1) permanent and one (1) alternate representative.
