JANUARY 27, 2023**

Greetings of Peace and Solidarity from PHILRECA!

With the power to grant franchises to persons engaged in the transmission and distribution of electricity now vested exclusively in the Congress of the Philippines as provided in Section 27 of the Republic Act No. 9136 or the Electric Power Industry Reform Act of 2001 (EPIRA), Electric Cooperatives (ECs) with expiring franchise presented challenges on the new processes for filing their applications.

To assist electric cooperatives develop and equip strategies and methods to ensure approval of application, PHILRECA will be conducting a **Webinar on EC Franchise Application on January 27, 2023 via Zoom**.

The workshop will provide orientation on the new process of filing the application for franchise in the Congress as well as provide templates and other necessary documents required.
