This is in reference to the Project of the United Nations Industrial Development Organization (UNIDO) and the Department of Environment and Natural Resources – Environmental Management Bureau (DENR-EMB) on "Implementation of PCB Management Programs for Electric Cooperatives and Safe E Waste Management."

Funded by the Global Environment Facility, the project aims to subsidize the disposal of the 600 tons of PCB oil/equipment at \$2/kg. In 2019, a series of meetings have been held with the ECs together with UNIDO and DENR-EMB in coordination with PHILRECA and NAGMEC. As of date several ECs have already signed contracts for this project while others are on the process of coordination.
